## PEFC standard to change in 2013

The PEFC standard (presently PEFC ST 2002-2010) will change in early 2013. The main changes are:

- A requirement to control health and safety (PEFC are catching up with FSC on this and those with FSC certification will have met this already)
- A considerable change to how timber from controversial sources is managed.

This last change requires companies to exercise due diligence with respect to where the raw material has come from. Most people reading this newsletter will be lower down the chain, buying paper and similar substrates from paper merchants. I would suggest doing the following:

- Add a line to your FSC/PEFC policy stating that material originating from controversial sources is avoided.
- 2. Be prepared for your auditor to ask you to gain confirmation from your supplier that controversial sources are avoided. (One can never predict the requirements of FSC/PEFC auditors.)
- 3. Be aware that most clause numbers have been incremented. For those of you with PEFC systems written by SSS, this will not affect you as references do not state the actual clause number. However, those of you with systems from other sources will need to check this.

# Goodbye to some health & safety regulations

In January 2012, the Prime Minister pledged to cut back the "monster" he says it has become, free business from the "stranglehold" of red tape it creates, and reduce the "pointless time-wasting" it causes for the economy. So I'm sure that you all will be relieved that the following regulations

have been scrapped during 2012:

- The Anthrax Prevention Order 1971 etc (Revocation) Regulations 2005;
- The Employment Medical Advisory Service (Factories Act Orders etc Amendment) Order 1973;
- The Health and Safety (Foundries etc) (Metrication) Regulations 1981;
- Non-ferrous Metals (Melting and Founding) Regulations 1962;
- Pottery (Health and Welfare) Special Regulations 1950
- Pottery (Health etc) (Metrication) Regulations 1982
- Regulations for use of locomotives and wagons on lines and sidings in or used in connection with premises under the Factory and Workshop Act 1901 (1906) (1906 No.679)

Sorry guys, but not much else has changed, apart from a sensible change to RIDDOR
