# HSE FFI budget set at £12 million

Information received under the Freedom of Information Act shows that the HSE have set a budget equivalent to £12 million per year for fees gained under the Fees for Intervention (FFI) process started on 1st October 2012.

Whilst I don't have a problem with the concept that companies who are at fault should cover the HSE's costs, rather than the taxpayer doing this, there is something wrong with this budget. At the FFI rate of £124 per hour, £12 million requires 96,000 hours or 55 man years per year. Or if we take a guess and say that each intervention will take 5 hours, then there needs to be 19,200 interventions per year. (Somebody, please prove my maths wrong!)

The HSE have stated that they have been running FFI for 12 months now, all up to sending out the invoices. However, now that this budget has been set, even if they are not going to hit it, it is reasonable to expect that HSE inspectors will be set targets and are likely to change from being proactive to escalating the levels of problems they see. This will hit both employers and equipment suppliers and will kill off the concept of reducing the health and safety burden on industry, as discussed in the September newsletter.

## Fire safety audit data

In the period 2011-12, the Fire and Rescue services carried out audits and actions as follows:

- 82,000 fire safety audits
- 50% were satisfactory
- 25,000 informal notifications
- 3,300 enforcement notices
- 600 prohibition notices
- 95 alteration notices
- 68 prosecutions

## Glad we checked the interlocks

During interlock checks on a Heidelberg Original Cylinder press and a Komori sheet fed press, one of our customers found that:

- · The interlock on one of the Cylinder's guards did not work, and
- Two nips trips on the Komori did not work, due to a build-up of hard ink which prevented movement

This reinforces what we have always said that it is critical to periodically check guard and nip trip interlocks; it is scary how many companies don't do this and assume that they will keep on working.
